EMDR Therapy Training Curriculum

The goal of this EMDR Therapy Training is to provide clinicians with a complete integrated training in EMDR therapy. This program supports clinicians in meeting the minimum standards established by EMDRIA, as well as specific additional curriculum in dissociation. The goal is to provide clinicians with the knowledge and skills to utilize EMDR therapy, a comprehensive understanding of case conceptualization and treatment planning, and the ability to integrate EMDR therapy into their clinical practices.

This EMDR Therapy Training is divided into Part One and Part Two, which include 31 hours of instruction and 21 hours of supervised practicum. In addition, there are 10 hours of consultation that must be completed. *Please note that trainees are not considered EMDR Therapy Trained until they have completed all of the aforementioned requirements and will receive a Certificate of Completion upon completing the entire course.*

Instructional (31 Hours): The majority of time will be spent teaching EMDR Therapy methods, as well as case conceptualization and treatment planning. The instructional component of this course is highly interactive; trainees will learn via combination of didactic work, videos and live demonstrations.

Supervised Practicum (21 Hours): The goal of the Supervised Practicum is to facilitate the demonstration and practice of the EMDR therapy methodology by trainees as outlined in the Shapiro text, and the EMDRIA Definition of EMDR therapy. To achieve the goals of the Supervised Practicum, practice may be done in dyads or triads. The role of the clinician is required, as is the role of clinical recipient. The role of "observer" is preferred but not mandatory; the number of participants will determine the availability of the Observer role during the supervised practicum. To help apply theory and practice, trainees will receive direct behavioral observation and feedback while they work on real life experiences. An additional EMDRIA Approved Consultant or Consultant in Training may help to facilitate the practicum under the consultation of myself. The ratio of practicum supervisor to trainees will not exceed 1:10 to allow for direct behavioral observation of each trainee.

Consultation (10 Hours): Consultation provides an opportunity for the integration of the theory of EMDR therapy along with the development of EMDR therapy skills. During consultation trainees receive individualized feedback and instruction in the areas of case conceptualization, client readiness, target selection, treatment planning, specific application of skills, and the integration of EMDR therapy into clinical practice. Trainees will develop and integrate EMDR therapy skills creatively into their existing practices in a way that enhances clinical efficiency and effectiveness in helping a wider range of clients meet their goals for change. Through consultation, trainees will be able to safely and effectively integrate the use of EMDR therapy into their clinical setting.

The 10 consultation hours are provided in developmental increments to extend over the course of the training. Trainees will be required to present actual cases in order for them to receive consultation on how to further develop and integrate their EMDR therapy skills in clinical practice. The 10 consultation hours are accomplished via 4 consultation meetings, in blocks of 2 hours each (8 Hours). In addition, 1 hour of consultation begins immediately after the Part One course, and another 1 hour of consultation begins immediately after the Part Two course (2 Hours). The consultation hours will be pre-scheduled, and under

extenuating circumstances may be subject to change to ensure that all attendees can benefit. Consultation hours are usually accomplished via a secured online video and teleconference system.

Participant Eligibility Requirements

Licensed Mental Health Professionals

- Qualifying Medical Doctors must be licensed to practice in their state or province.
- Qualifying Advanced Practice Registered Nurses must have a Master of Science in Nursing (or higher) with a specialization in psychiatric mental health nursing and must be licensed to practice through their state board or province.
- Qualifying Mental Health Clinicians must have a Master's Degree in the mental health field (Counseling, Marriage Family Therapy, Psychology, Psychotherapy, Psychiatry, Social Work) or related mental health discipline and be licensed to practice through their state board or province.

Pre-Licensed Mental Health Professionals

- These are clinicians who are actively pursuing a mental health license through their state board (or province) while working under a licensed supervisor. Some of these license types may include: associate, intern, limited, provisional, temporary and prelicense.
- Qualifying Pre-Licensed Mental Health Clinicians must have a Master's Degree in the mental health field (Counseling, Marriage Family Therapy, Psychology, Psychotherapy, Psychiatry, Social Work) or related mental health discipline and must be actively pursuing a full license through their state board (or province) while working under a licensed supervisor.

Graduate Students

- Qualifying graduate students must be enrolled in a Master's or Doctoral program in
 the mental health field (Counseling, Marriage Family Therapy, Psychology,
 Psychotherapy, Psychiatry, Psychiatric Nursing, Social Work) or related mental
 health discipline. Students must have completed their core graduate academic
 coursework and must be in the practicum/internship portion of their graduate
 program. First year graduate students are not eligible. Graduate students must be
 on a licensing track and working under the supervision of a fully licensed mental
 health clinician.
- Graduate students who would like to take an EMDR Training will need to submit certain documentation (graduate transcript, practicum or internship details, and a letter from their supervisor which includes the supervisor's license information and number) in order to verify their eligibility.

I am also aware that the experience of being "client" in this course not only provides me with the opportunity to experientially learn what it is like for clients to do EMDR therapy, but to also provide other participants with the opportunity to experientially learn EMDR therapy
I also understand we will address personal issues as part of the EMDR Therapy training process, but these experiences do not constitute the existence of a psychotherapy relationship with training participants or the trainer.
I am aware that if I am currently under the care of a therapist or psychiatrist that I have informed my provider that I am seeking to attend the EMDR Therapy training. I have discussed this with my provider, reviewed my readiness for pursuing the training, especially the experiential portion, and have obtained his or her agreement of my readiness to attend and fully participate
I am aware that if I am currently under the care of a medical professional for optical issues, a heart condition, or pregnancy that I have discussed this with my provider, reviewed my readiness for pursuing the training, especially the experiential portion, and have obtained his or her agreement of my readiness to attend and fully participate
I also understand that in addition to participating in lecture and practicum experiences that a large portion of the EMDR Therapy training will include, but is not limited to, the discussion of trauma related topics and content, case studies, case consultations, videos, and in person demonstrations. I am aware that the nature of EMDR therapy, and therefore the EMDR Therapy training itself, is potentially activating of trauma related personal material
I am aware that as part of my informed consent to participate that it is my responsibility to ensure that I have sufficient coping skills, calming skills, and distress tolerance to be able to manage my response to potentially activating traumatic material through this EMDR Therapy Training

If I currently have been diagnosed with and/or have been receiving treatment for and/or it has been recommended that I pursue treatment for complex PTSD, a dissociative disorder, or substance abuse, it is my responsibility to inform the trainer in advance. A failure to do so could not only impact my learning experience, but also my mental health, others' learning experiences, as well as my ability to complete the EMDR Therapy training.
